CC Report from Council Chair Gail Black

Our state office continues to run smoothly handling monthly duties including our monthly magazine, monthly financial reports, answering the many inquiries that come from Lions and our communities. This is very important as it will affect future Governor's budget that they are given for their year from Lions Clubs International for reimbursement of their monthly expense permitted by LCI's rules of audit. By not turning in your reports it will reduce next year's Governors expense reimbursement. If you have any questions or need help please don't hesitate to ask me.


Financial reports of our state office from July 2017 through June 2018 are completed but not reviewed by the finance committee. Our 990 tax return has been filed before November 15, 2018 which is the due date. A increase in net membership of 19 new members for the first four months of the 2018-2019 lions year. Dues income is even with budget. As a reminder budget showed membership with a small decline and actual shows a brake even which is better than expected. Districts are having a challenge from collecting dues from a few clubs, which in turn are not paying total amount due to the MD 36. Right now this isn't affecting our cash flow materially but it could in the future if this trend continues. We have also had a few requests to write off dues owed to the MD by cabinet treasurers due to club billing errors or none payment of dues. I have done six years of graphs of our membership by month to show what has been happening to our districts. Our office computer took a vacation but is now back to work.

Our challenge continues to be meeting the wants of our council as a whole while learning to do with less funds.

Unfortunately there are still many Activities, Service Projects and Fund Raisers that are not being reported to MyLCI. We just keep encouraging Clubs to report them.

Many of have taken Leadership training by attending classes or using the online Lions Learning center. For those still taking Leadership courses online, we advise the GLT Lion Sharon Rollins know, when they have completed a training session, so she can put that into her report.

We are encouraging Clubs to try to get 1 or 2 Lions to the Northwest Lions Leadership Institute in April 2019. There are still some \$100 Scholarships available for first come first serve basis. The course will be in Keizer, Oregon from April 26th through 28th 2019, and the deadline to apply is April 12th 2019.

You can down load the application from the Multiple District Website.

Membership always seems to be going down this time of year, but we are up a little from last year. As Clubs delete nonpaying members, those who have moved out of area, or who have passed away, we usually see a further drop in membership.

This does not have to happen if all of the clubs make a concerted effort to bring in more members before the end of the year, and be sure to contact those behind in their dues one more time.

I remind Clubs of the demographics showing, that for every new member joining, they will have an impact on 70 lives.

GMT Lion Lulu Bowman and 1st VDG Lion Terry Bowman are working hard to start a new Club in Tillamook this year. They are getting closer, but could use a few more prospects. If any of you know anyone in that area, please get their contact information to them ASAP.

At this time another 30 New Members would put us back over a 1,000 District O Lions.

GST Lion Fae Lloyd, has been working on a project, where she is attempting to list all of the different Social Services in a given area to make a resource for homeless and those having great needs in their life. Often there is help available, but they don't know where or how to obtain that assistance. I am told there have been attempts in the past to create resources lists, so if you should have information please contact Lion Fae with that information. Fae is also pioneering a project, where they print up some posters that say "WE APPROVE" and she inserts the local club's name, and then below that, lists some of the service projects done in the community. This is done with the permission of the owner of the store.

My District service project continues at the Club Level for now, our Clubs are collecting used Purses, Travel Bags or Shaving kits, and if possible filling them with 1st aid and Feminine Hygiene items. We are asking folks to decorate them with a "Beyond the Horizon" theme. We will have contests for the best decorated bags at the club level, then each Club will bring their winner to the District convention for a run off. The District winner will go on to compete at the Multiple 36 Convention the 1st weekend in May 2019 in Seaside.

The winner of that contest will receive the coveted Guiding Lamp Award.

This should be lots of fun, and provide each District with some tools for service.

Our Lion Friends in Paradise, California are in need of our assistance as many of you have already heard. Please contact PDG Lion Wes King for the most current details, as he is heading up the efforts to send supplies and/or Money to them From Our Multiple District.

The needs change from time to time, so Lion Wes will be staying in touch with the Lions Down there.



#### MD 36 POLICY COMMITTEE

## **COUNCIL OF GOVERNORS**

The committee has updated a few of the policies and have redlined the changes for your consideration. We are working on the GLT, GMT, GST and GAT policies. The LCIF policy, Awards and Convention seem to need some updating as well. While looking all this over, we have some recommendations.

- 1) There are several areas where basic housekeeping needs to be done, such as eliminating reference to the office "building" and updating some of the ways of the committees to correspond (via e-mail of course) and even ways to have meetings (via teleconference or internet).
- 2) Reporting is inconsistent among the committees. We recommend a standard that can be used for most committees. There are a few that require specific or regular reporting and we wouldn't change that. This language is recommended for most: Reports: A typed report will be submitted fifteen (15) days prior to COG meeting if requesting COG action or requested by the COG. Otherwise a report may be submitted orally and/or written to the COG at the COG meeting.
- 3) We recommend changing the paragraph titled "Committee Make-up" to "Composition of Committee" This is easily accomplished.
- 4) Meetings: This seems to be the most inconsistent and needs to be updated. We recommend a standard for most committees (again, a few such as budget, convention and the GAT group should continue quarterly meetings. A standard such as

### Meetings:

## A. Regular:

- 1. Should be held at least once yearly with that meeting being held in the fall or at the Multiple District (MD) 36 Convention.
- 2. Additional meetings may be held at the discretion of the committee Chair and may be done in person, via telephone or by e-mail.
- B. Special: May be called by COG or the Committee Chair stating the time, place and purpose.

If you agree to the above recommendations or most of them, we propose redoing the policies as a package, much as Richard did in 2014. We need to contact most of the Committee Chairs and will continue report on this at the next meeting, hopefully with a good draft. The goal would be to adopt the newly revised policies at the May Council meeting.

#### Oregon Lions Sight & Hearing Foundation Council of Governor's Report December, 2018

The Foundation and MD-36 Lions led the way to successfully pass SB 187 during the 2017
Oregon legislative session. This legislation is providing \$1 million in funding for schools to be
able to afford vision health screenings for Oregon students grades K through 8 during the
completed 2017-18 school year and during the current 2018-19 school year.

We are now preparing to introduce legislation to the 2019 Oregon Legislature that will continue this funding for the 2019-2022 biennium. An opportunity for Oregon Lions to support this effort will take place at the State Capitol in Salem on April 24<sup>th</sup> for Lions Day at the Capitol. More details will be coming on this important effort of advocating for children's vision health.

• In January and throughout 2019, OLSHF will celebrate 60 years of Service. Founded in 1959, the Oregon Lions Sight & Hearing Foundation was established to help local Lions Club provide sight and hearing services without having to shoulder the financial burden of doing so. Our first program, Patient Care, continues to provide critical surgery and treatment for Oregonians lacking the resources to have their sight and hearing restored.

The Foundation will celebrate this important milestone at every Lions Convention in 2019 and will promote ways that Lions can join in the celebration through information in the Oregon Lion magazine and through social media.

- OLSHF welcomes the new members of our Board of Trustees: Vice District Governors: Terry Bowman, Rockaway; Steve Moser, Central; Bob Chaney, Myrtle Creek; and Gary Mose, LaPine. Trustees serving three year terms: Hope Loose, Oregon City; Fran Camacho-Silbernagel, Stayton; Carol Swesso, Sutherlin.

MD 36 Lions Alert Report to Council of Governors December 1, 2018, Springfield Oregon Co-chairs Sheri Young (Wilsonville) and Charlene Larsen (Astoria)

Our 3 levels of focus continue to be

- (1) for all Lions and community members: personal and family disaster prep (shelter in place + go bags/cars) pre-prepped for evacuation
- (2) local Lions Club coordination with government and non-profit/faith based response at a local community level and between neighboring communities
- (3) District and Multiple District Lions Club coordination on disaster prep and response
  - between ourselves and
    - (1) ORVOAD (Oregon Volunteer Organizations Active in Disaster) -- which is our state level connection with Oregon Emergency Management (our path to FEMA recognition) and
    - (2) LCIF. Through which coordination we can create better paths to responding when there are emergencies out of Oregon/our district as have occurred this year in particular in northern California fires.

At the level of inter-district response (MD 36 to Northern California District 4 C 1) the challenge this season has been response to the "Camp Fire" and "Paradise" fires in northern California. About 27,000 people lost their homes and were displaced. Paradise Lions were among the displaced, and Chico Lions have been at the forefront of response.

LCIF disbursed a grant of \$10K to that district within 24 hours, and Chico Lions set up facilities for managing donations. Lion Wes King of District 36-E took leadership on outreach. This MD has forwarded funds to/through LCIF and directly to Chico Lions via their community fund. Chico Lions are serving about 100 applicants daily, processing donations (especially food and clothing) from multiple faith-based organizations, and managing ad hoc volunteers. Blankets are still needed and clean-up tools and supplies.

We thank Lion Wes King (MD-E Brookings) for taking the lead on this response and verifying the response Chico Lions are providing.

This will help us in formulating a matrix for Lion response with ORVOAD.

This is a summary report about Camp Taloali (CT) that relates information of how Camp Taloali has progressed in the last five years, and especially in the past two. When I was asked to join the Board of Directors in September, 2013 CT was in financial crisis. Our bills were being paid by individuals as donations to CT and we had only one certain means of income. We had very little money in the bank, except the money for camperships which are restricted funds. We could not have opened the Camp for the Deaf and the Hard of Hearing without money raising by PCC Keith Price and PDG Doug Fiala. Then, having gotten funds, the reconstruction and repair work was quickly completed by The Crooked River Ranch Lions Club and the Camp was opened shortly thereafter.

Our Chair of the Board of Directors is Janet Johanson, an extremely adept person who uses hearing implants and signs and translates American Sign Language (ASL) extremely well. I have just taken the temporary position of Secretary of the Board of Directors again due to an illness in the family of our just previous Secretary. I am pleased that Janet is our Chairwoman because she runs meetings according to agenda and we move quickly along.

The first thing that you learn while dealing with Deaf People is that: Because a person communicates by a different language (ASL) that absolutely does not affect their mental capacity. Good ideas come from all of our Board of Directors. We have to realize that ASL is an easy method to communicate ideas but that writing ideas takes longer than it takes other people to present them. ASL users must be patient with non-ASL people writing things such that things can be read.

That is why, now that I am able again after slowly recovering surgeries, I will come to speak about Camp Taloali to any Lions Club, Zone Meeting or Cabinet Meeting to present information and the wonders of Camp Taloali to Lions and all interested parties. All that you need to do is ask. Email requests are better and Tuesday nights from December through mid-march are difficult. We will arrange times.

Mr. Ishea Rosen works at Oregon State University. He is the chair of our fund raising committee. He continually brings ideas to the Board that are easily considered by us. Ishea, like most of the Board of Directors, does not hear but writes excellent reports and proposals for fund raising. He is involved in

grant writing requests but we need someone on our Board that has experience and knowhow regarding creating those requests.

We will have three sessions of camp this coming summer with a maximum of 72 campers per session. Both the deaf and siblings of the deaf are welcome at CT because hearing loss affects whole families. I know of one young man who speaks and hears perfectly and communicates with his family using ASL because his parents and brothers and sister do not hear. (He already knows a second language for university credit.) ASL is usually available at Community Colleges and Universities.

In April, 2013, I met the Board before we started our fund raising activities. Even though I did not and still do not use ASL, I was accepted with open arms because I had committed to help them get the Camp open for the 2013 season.

During the eclipse in the summer of 2017, Camp Taloali rented cabins (sleeping quarters), camping spaces for tents and Mobile homes and served meals from the Pavilion kitchen for income. The event was highly profitable. It is too bad that eclipses do not occur yearly here. We had campers from New Mexico and Arizona stay at CT along with a couple from Spain.

Shelly Barber organized our August 28, 2018 Haunted trail. I ran from 8:00 PM to 11:00 PM and in the daylight, the trail took approximately 25 minutes to traverse. We started parking cars in our big fields at 6:20 PM and continued to give parking directions until 9:30 PM. Our Patrons at the end of the line waited approximately 90 minutes to start their trail hike. I estimate that 1500 people went through the line with the last finishing at 11:30 PM. A long night. The income was over \$10,000 (US).

We are not renting the area to more groups that simply want a private place for their camping activities. It is both profitable and expands the knowledge that CT is a nice place and is accessible. We have our own restrooms and water supply. Out well is potable.

A group of people in the Architectural Department at The University of Oregon are giving us a design so that we can double our cabin sleeping capacity. All we did is ack them to help us. This is necessary because of new restrictions required by the American Camping Association who regulate how many councilers are required for a certain number of campers. By doubling the cabin size and we are still be legal with two councilers per cabin so we will then have 14 campers in each cabin or a total of 168 campers possible per session. For three camping sessions that would be 504 campers. The cabin engineering work is being done by someone volunteering for U of O Architect Department and not by this writer. Until we have the stamped plans and structural calculations we can not ask Marion County to see what we have for Building Permit.

We keep in mind that all cabins might not be easily expandable without certain tree removal.

Another advantage of expanding the cabins is that we will have more space for renting to special groups

of patrons. The Deaf TimberFest is held each year at CT.

We have greatly expanded our advertising capacities by using Facebook, The Internet and other Electronic Means.

Camp Taloali has an 18 hole DISC Golf Course that we rent to golfers and organizations all year long. Disc Golfers are just as crazy and regular golfers in that they play rain or shine.

We need Lions Clubs to participate in:

- 1) Purchasing Camperships for the Deaf and Hard of Hearing Children to which we cater. This year we will have children from west of the Rocky Mountains and perhaps other areas because we have learned to advertise effectively. A campership for a one week session costs \$400.00 (US). Lions Clubs can send any amount for campership money to Camp Taloali. Please designate "for camperships" with your donations.
- 2) Because of possible gas leaks, we think that we need a new stove. A gas stove is expensive. About \$10,000 (US). I am looking to see if we can get the gas system rebuild for steel, not aluminum, burners.
- 3) A new dishwasher is needed and both the high heat and the low heat machines are about \$500.00 (US). I believe the high heat machines require a higher voltage than we have available.
- 4) We will need funds for cabin expansion and cabin repair. This is something to which Lions Clubs can donate. Because we have not received the final plans, I do not know the cost of repair or reconstruction.
- 5) The Pavilion kitchen needs to be reworked. A lot of hand work such as cleaning and painting will have to be done. Walls may have to be revitalized. This sounds like a Lion Club project.
- 6) Slightly used clothes washer and clothes dryer have been purchased for the CT kitchen. Clean towels are a necessity. The \$900 (US) was paid by a Board Member.
- 7) We have events scheduled 2019, including a Wine Tasting and Face Painting Party in February. I have donated three bottles of wine and since I do not drink or like face painting I still have a good time.

Most of the on-site buildings were designed and built by teams of Lions and Deaf Persons. Stan Teets, the son of Royal Teets who worked with Lion Walt Trandum in the CT building processes, is on our Board of Directors. Stan is an extremely valuable source of information and an inspiration to all of us because he was there every day during the construction processes.

Plans have begun for the 95<sup>th</sup> Annual MD 36 Lions Convention. This event will be held in the Seaside Convention Center, May 2-5, 2019. This is always a great place for our convention and it's well attended. This year, we will see the new look of the convention center. It is going through a major renovation that includes moving the East and West walls out to the street, enlarging the "Riverview" rooms upstairs, enlarging the lobby, moving the staircase and much more. Most of the work will be completed by the time we arrive but we can expect to see some finish work during our time in Seaside. This expansion may allow us to be more creative in how the convention is formatted. Watch for more information!

I've made a trip to check on construction, catering and lodging. This has been challenging because as we all know, the price of food and lodging just continue to increase. Over the past 6 years, we have been able to hold the registration packet fee to \$100.00. (A 5% increase in food cost is expected in January, 2019). We had been able to keep costs down and we had better membership numbers which means more funds into the Convention fund. In May, 2018, we worked hard re-negotiating the contract at Valley River with new owners and a decrease in our attendance numbers. However, when all the dust had settled, we spent \$13, 000+ more then we collected. Thankfully, we have a reserve account that we watch closely and that allowed us to cover all the expenses. While there are still funds in that account, we cannot afford to lose that amount of money again this year!

I'm asking your approval to set the Registration fee for the 2019 MD 36 Convention at \$125.00. In addition, I would like to request \$3000.00 advance from the Convention Account. We will do everything in our power to keep expenses as low as possible and work to increase the attendance. I would ask that you also help to promote the convention. Having better attendance helps with the budget and it also helps strengthen our Lions!

To date, I have contract information with two hotel management teams that operate four hotels in Seaside. I hope to have signed contracts before the end of 2018 and I will make that information available to all of MD 36 as soon as that is finalized. I would also like to have some of the other hotels/motels make offers for reduced rates, so watch for information coming soon.

- 3. Funding for the Lions Quest program has been changed by Lions Clubs International Foundation (LCIF). LCIF has placed Lions Quest in a separate grant program, no longer associated with the Core 4 grant program. Local match of funds is still 1/4. Remember, Oregon has three sources to contribute that 1/4 match.

(Reading Education Assistance Dogs) is a program started by ITA which has become not just the first, but the best, the most powerful and effective literacy support program in which kids can experience the joys of reading and books. It happens in the best possible way, through the companionship of a R.E.A.D.-trained therapy animal at their side. Since R.E.A.D. began in 1999, they have registered more than 4,500 therapy teams throughout the world. R.E.A.D. teams in all 50 states and 13 other countries are donating their time and expertise to help children improve their literacy and communication skills.

**READING EDUCATION ASSISTANCE DOGS:** Reading is indeed fundamental, but for many, learning to read is overwhelming. Across the nation, dogs are lending their ears, and thousands of children who need extra help with reading and communication skills couldn't be happier.

#### **But Why Dogs?**

Animals are ideal reading companions because they

- Help increase relaxation and lower blood pressure
- Listen attentively
- Do not judge, laugh or criticize,
- Allow children to proceed at their own pace
- Are less intimidating than their peers

**Imagine this scene:** "For each session, the dog and the child-tutor settle down onto a blanket-covered pad on the floor in a corner of the library. Either the dog picks out a book or the child selects a picture book, brings it to the dog, holds it flat and begins to read."

Though the children believe they are teaching dogs to read, in fact, with the dog as a comfortable, attentive audience (and an occasional gentle assist from the dog's adult volunteer partner), they are actually teaching themselves. As far as the child is concerned, however, reading is about the dog, not about the child; No pressure; No embarrassment; No humiliation.

Lions Clubs International has observed and sponsored a program to instill the ideas of cooperation to "Promote understanding amongst peoples of the world" as a tenant of operations. This has been done for about 50 years through the efforts of the Lions Youth Exchange Program. Oregon once had a great operation – sending as many as 30 youth to foreign countries – especially to Australia. We hosted many at camps as well. Now – almost nothing, yet the need is there.

In the past 20 years, I have had the real privilege to host quite a number of youth – mostly from European nations, although several from each New Zealand and Australia have spent the Christmas Holidays in the Hood River area. Most countries in Europe and elsewhere have summer camps – where youth from other countries arrive, have a group camp for about 10 days to 2 weeks, and often followed up with individual family hosting for several weeks.

Oregon – MD 36 – had for a number of years a mobile camp – a number of volunteers with their motor homes – hosting normally 3 or so youth at a time and traveling around this glorious state for ten days. They went on one of three routes – Salem to the Coast and north, ending back in Salem; Salem or Junction City and south to Grants Pass and the Oregon Caves then to Crater Lake and on to the Bend area; or the third leg – again Salem or Junction City to Portland and up the Columbia Gorge to Hood River, then The Dalles Rodeo, on to Baker City and lastly to the Bend area. These trips were sandwiched between either a single host family or two hosting events. Kids spent from 4 to 7 weeks in Oregon, learning about our families, our American Customs, learning to hear, understand and speak English better and having a great time going to places of interest, to games and events and in general – being a family member.

Youth can be from 15 to 22 years of age, have to be sponsored by a Lions Club from their country of origin, usually pass a background check, sign papers with their families to abide by all laws of the US and state of visitation, and abide by the wishes of the host families. Host families are often Lions members of a club in good standing, but do not have to be. Youth are, however, sponsored by host Lions Clubs, no matter where they stay. Host families are checked out as well, although it is a cursory background check. What is required is that the host family have the room for the youth – separate or shared bedroom with own bed. Often host families have kids of the same age – although there is no requirement that the host have children of their own. I usually host two or three youth at a time – with the caveat that they are from different countries. For those visiting the US, they must have a fairly good background in English – and most European kids have had up to 8 years of English language in school.

So – who do we have or know who would like to experience the hosting of youth from a different country, get to know how they live and experience the joys of having kids around to 'show off' to friends, relatives and neighbors? Youth come with around \$75 per week spending money, and families hosting are expected to feed and house them. Voracious appetites abound, but nothing extra-ordinary is expected. I do a trip to the Coast, visit various areas of both interest and beauty, see a baseball game, try to get to a rodeo and the 4<sup>th</sup> of July festivities, topped off with Crater Lake!

From the Protocol/Parliamentarian Chairperson

Council Chair Gail and Governors:

In looking through the Policy Manual Description of this office, I discovered that I had forgotten or not realized that Protocol is also responsible for making sure that Lions know about our LCI emblem, also referred to as our logo.

Unfortunately, the LCI By-Laws are vague about actual policy but to synopsize the article: The name, goodwill, emblem and other insignia of the Association and Lions clubs chartered thereunder may not be used for any purpose except those expressly authorized by the International Board of Directors. No other individual or entity may use the name, goodwill, emblem or other insignia without written consent and license as shall be required by the Board.

So, simply, those folks or companies who embroider or screen-print our shirts, caps, vests have to obtain permission from LCI to use the emblem. I suppose you could also make a case for the printers who print out raffle tickets, stationery, flyers, etc.. You can see that it is a slippery slope. So I urge you Governors to be alert to possible infractions of the licensing language. What is your remedy? Depends on the extent of the infraction. This is what the legal department at LCI is for - to help you interpret the intent. Use them, they are there for you.
