I need to get a feeling about the direction that I have preceded thus far. You have been sent an email regarding the concerns around the replacement process. The budget committee met due to the fact the budget for this year will be affected. The new hire should go through the MD Convention process. We cannot afford to operate as we have in the past due to the fact that membership is declining. With the new hire, changes in the way we operate can be considered, i.e. such as a home office is feasible. The position could be part-time existing of 30 hours a week. We could use the help of a temp agency. I estimate the cost for additional salary plus agency fees would run between \$8,000-10,000. Refer to the attachment submitted.

The consensus of the Council was that PID Ed Gear was moving in the right direction in finding a replacement for the position of Executive Secretary. The Executive Secretary indicated the committee will need to look into extra storage, perhaps a storage unit. Also a cost of a designated phone line in the home of the new hire for Lions purposes only.

There several issues that cannot be resolved until the new hire is in place. This would include the budgeting process. A question of supervision by DG Wes was addressed. The new hire really needs to be an independent worker and be able to work without daily supervision.

Does the HQ Office need to be based in Eugene? That would need to be looked at.

A motion was made to allow PID Ed to continue the general plan he has outlined in his report to the Council by DG Chuck Blanchard. The motion was seconded by DG Hank Calhoun. Motion carried.



District 36-O Report

November 2015

It's a great day to be a Lion. It is very important to be "all in" as we work to support Lions and Lion Clubs as they serve their communities. As Lions we need to treat "Humanity" with "Dignity" while we work together in "Harmony".

This year to date, District 36-O is doing well in regard to membership. We have one new Charter Lions Club; the "Gales Creek Centennial Lions Club" which is the only diabetes camp Lions Club in the world that we know of. We are also working to get two branch clubs in our district to charter before the year is out. All of my Zone chairs are checking for communities that would be ready and would support a new Lions Club. District GMT Chair, PCC Lion David Rich, has put together a packet, the "I Can Plan" that clubs can use to make their clubs grow. It is a great day to be a Lion!

Currently there is one newly chartered club, three clubs on Status Quo, with a total of 44 active clubs, and three branch clubs. We have 89 new members and 57 dropped members with 4 members that have passed away. At this time we have a net gain of 28 members for a total of 1,119 Lion members in District 36-0. It is a great day to be a Lion.

Global Leadership Team Chair Lion Diana Richardson has put together a great team that has done a great job of training officers. Because of their work and organization, our district has a number of certified Guiding Lions to help new and struggling Lions Clubs. I am very proud that the District GMT/GLT teams have been working together with joint meetings. They include Zone Chairs and the Executive team to their planning meetings. Thank you Lion leaders for working together in Harmony.

The clubs that I have visited this year have goals and plans related to membership and growth. Most Lions Clubs are continuing with the "Ask One" and trying to ask younger members to have the experience of serving others. Many of the clubs have either a Facebook Page or a Web Page. This is an important part of communicating and drawing young members to Lion Clubs. These same clubs are also increasing the opportunities to serve. It is a great day to be a Lion.

I have visited 30 Lions Clubs and one Branch Lions club at this point in the year. I have been giving origami Cranes, round "tu its," and one million dollar bills at my visitations. I have also had the honor to install around 15 new members. My goal is to have more that 150 Lions at the District 36-O Convention on February 20th in Gresham. The Convention is a great deal at \$25, which includes Lunch.

Governors Report District 36R Council of Governors Meeting November 14, 2015

We are having a good year in District 36R. I have visited 26 Lions Club in the District. I plan to complete visiting all of my clubs by mid-December, except for two that are scheduled for visits in 2016. I am delighted to find how active and involved in their communities the clubs are. Even the smaller clubs in the District are doinug amazing service. And I have had a few surprises. One of the best was to find that the Mt. Angels Lions have Branch Club. The Branch Club consists of five developmentally challenged men who are part of an adult day care at the Benedictine Sisters Abby. The Branch Club members participate in club meetings, service and fundraising activities. The also do their own fundraising to pay their club dues.

On November 7th, we held one of the most successful District Cabinet Meetings in recent years. We had 30 to 32 Lions in attendance – our largest turnout in a couple of years. We had two interesting presentations during the meeting. The first was on Tail Twister presented by Lions Lee Wacker from the Springfield Lions and Chuck Cook from the Junction City Lions. They are the two best Tail Twisters I know and their presentation was outstanding. I'll rent them out to you for a fee. The second was on Project Planning and Management presented by Lion Steve Moser. There was a lot of interest in both presentations.

We are still working on putting together a Women's Symposium to be held in the spring. We are having to face reality: the cost to rent a venue is higher than we originally estimated. We have not given up on the idea of a Women's Symposium, but we may be forced to hold it in a less expensive location than Eugene/Springfield.

The Campus Lions Club at Western Oregon University continues to grow by one to two members per week. We are currently at eighteen members and hope to apply for a charter by December 1st. We are delighted at how easy it has been to get this club going, We are looking into starting a Campus Club at the University of Oregon after January 1st.

VDG Judy Kauffman previously discussed a "101 mile on Hwy 101" bike tour. The Newport Lions have had to change their idea due to some significant safety issues – riding through Lincoln City and the Cape Perpetua area. The concept is now "101 km on Hwy 101". The tour will start at the south end of Lincoln City and end at Yachats. Lion Judy points out three significant advantages for a club that sponsors a bike tour.

- 1. The company does almost all the work
- 2. The club can raise \$1000. 2000.
- 3. The Lions logo will be everyplace good publicity for the club and for Lions.

We continue to work on membership. We have clubs that are adding new members, but they are only slowly showing up on the LCI reports. It's coming along and my sense is that LCI's reports will eventually catch up. I am doing everything I can to encourage

clubs to increase their membership and to get their clubs ready for new members. I bring a copy of four documents on each club visit: Just Ask; Your Club Your Way; Membership Satisfaction Guide and Blueprint for a Stronger Club. Member retention and new membership is an important part of my discussion on every club visit. My hope is that the clubs will make use of the information and strengthen every area of their operation.

Progress has been good on my goals for this year. I have visited 38 of 41 clubs so far with the remaining visitations scheduled by the end of the calendar year.

PDG Bill Branham and I are currently working on starting a new Lions club in Medford. We have at least 6 younger potential members (30 to 40 years old) who desire to become Lions in a new club in the Medford area.

Our 2nd Cabinet meeting was held on November 7th in Keno OR. Like our first cabinet meeting, which was attended by 48 Lions our 2nd meeting was also well attended by 50 Lions and one Senior Firefighter. The Firefighter presented information about a new system to assist all fire fighters get essential information about an incident in real time, using their smart phones. The system will most likely be adopted state wide in the near future. Information about the Centennial Service Challenge, Children's Dignity Week, Centennial membership pin and certificates, Lion's University and the Treva Hoffman Foundation was presented.

The Lions Club handbook has been extremely well received. I'm having trouble keeping enough books on hand to satisfy the demand. I have ordered another case of the books which should be available soon. Demand is so high that USA/Canada Forum had to order a new printing of 5000 books.

Most of the clubs in district 36-E are very active and doing very well providing the excellent services that Lions provide. There are a few clubs that I will be working with to assist them to become all that they can be. The "Ask One" pin is one way to help break the ice and begin conversation about Lions clubs and the services they provide in a particular clubs area. I have encouraged Lions to wear the "Ask One" pin on a daily basis. It won't be long before someone asks why they are wearing the pin. There is your ice-breaker.

Council,

I am scheduled to meet with the Council when you meet on Nov 14th. I have been asked to work with a committee to find a replacement for Glynis when she retires.

In planning for the meeting on the 14th I have developed several questions that need to be answered by the Council before we can go much further in this process. I don't want to surprise you with the questions and discussion on the 14th so I am sharing many things I think we need to discuss so the committee can move forward following the meeting. The date for Glynis to retire is June 30th. To allow a new person to be adequately prepared to assume the job it would be desirable for them to start work on May 1st, 2016. This allows the new hire the opportunity to attend and the MD Convention and work with Glynis in this process. We need to have the approval to move forward with this as the hiring date. During that two month period we would be having two employees with some extra expense.

One consideration would be to change the position from "Full Time" to Part Time". I believe that could be done by a couple of changes in workload. Our MD Membership has steadily decreased for many years and while each year intentions to reverse that trend have been admirable the fact remains we continue to lose members. In Districts all across the country the District Governors communicate with their District members directly instead of through a MD publication such as ours. If the MD Sec. published two or three MD Communications per year, we could still have some communications from the MD. Also the Districts and MD have web sites that can communicate with our members. I think the changes I am suggesting could be done easier with a new hire rather than changing later. Another area that could reduce the workload of the new hire would be to eliminate the MD Sec duties associated with the MD Convention and give those to the MD Convention committee.

Another change that could be made to save money is to have the new hire work from a home office rather than have the \$10,000 plus office expense. There still might be some smaller expense associated with setting up a home office and or small storage unit.

I have been doing extensive research into either an individual search or using a Temp Service for assistance. I will talk more with you about this on the 14th. 3600 For 520 Ar 9008, 9000, 9000

I have a list of our current expenses associated with our current practices. I will also share that with you on the 14th. However, the important question is to determine if the committee can develop a plan for the new pay scale and other expenses or how we are to move forward in this process. One concern I have is that the Council only meets once in March prior to having to have all of this accomplished NLT May 1st.

I have also been gathering materials from a variety of sources to put together a comprehensive job description to use in hiring a new hire. Our Job Description in the Policy manual is not adequate for this purpose. The final Job description will be determined by the answers to the questions I have in moving forward with how we structure the work of the new hire.

Can I , working with the committee, set things like Vacation, Holidays, Sick Days etc. Also a similar question exists concerning how we do the selection process. Title: Executive Secretary

Report to: Executive Administrator

The Executive Secretary is a skilled administrative professional who provides a wide range of support services to the Lions Clubs of Multiple District 36 (Oregon and Northern California). It is a position where the person works almost totally independent. The Executive Administrator is a non paid Lion appointed by the Council of Governors to provide a single person to give direction and general supervision to the Executive Secretary. This is a part-time position of 30 hours per week, with a starting pay of \$20 per hour. Good people skills are required for both telephone and face to face discussions with Lions.

The following skills and tasks will be required of the Executive Secretary to perform this job.

Knowledge: Clerical

Knowledge of administrative and clerical procedures and systems such as:

- 1) Word Processing, In Design, Photo Shop, QuickBooks Pro, Outlook, Squarespace (internet), Microsoft Office,
- 2) Microsoft Excel, FileMaker Pro, Otter, Acrobat, and Chrome.
- 3) Internet technology Updates of the Multiple District Website (Squarespace)
- 4) Filing and maintenance of records.

Financial Duties

- 1) Accounting using QuickBooks Pro, Accounts Payable, Accounts receivable, Invoicing, and maintaining checkbook.
- 2) Payroll taxes using QuickBooks 941 Schedule B for Federal taxes and Otter for State taxes.

Meetings

- 1) Travel and lodging expense account for meetings.
- 2) Multiple District Convention. Once per year.
- 3) Three other Council meetings at various locations around the state of Oregon.

Publications

- 1) Publishing a periodical magazine using InDesign Program and Photoshop.
- 2) Publishing a yearly directory using InDesign Program as well as Microsoft spreadsheet for maintaining mailing labels.



Report to the Council of Governors November 14, 2015

- The Foundation's MHSP program is off to a record-setting start this school year, screening over 72,000 students to date since the start of school in September. We're operating at a slight increase over last year at this time, when MHSP screened 158,000 during the entire school year. To date, the MHSP school event referral rate for vision screenings is 9.8%
- The Foundation's new LEAP Optical Finishing Lab is continues to add Lions Clubs and optical providers throughout MD-36 to our network of LEAP partners. So far we now have 24 Lions Clubs and 18 Optometrist providers as part of the LEAP network. These Lions Clubs now save between \$75 \$100 every time they help a person in need with new eyeglasses and will now be able to help more people.
- The Foundation's Lions Mission Cataract program now has over 30 Ophthalmologists
 across the state donating cataract surgery to people in need. We actually have surgery
 slots available and want Lions Clubs to promote to their communities the opportunity
 for Oregonians lacking health insurance to benefit from this program. Please contact
 staff at OLSHF to receive information on how to promote Lions Mission Cataract in your
 community.
- OLSHF's ROAR! Hearing Aid Bank program has developed a new relationship with
 Starkey Hearing Aids. Starkey is selling brand new digital hearing aids to the
 Foundation for \$125, about the same price as we currently pay for refurbished hearing
 aids through RJS Acoustics. The Foundation will continue to work with RJS but Sight &
 Hearing Chairs are encouraged to contact the Foundation if they are interested in
 learning how to access the new Starkey hearing aids for the people they help.
- The Foundation is in the midst of information gathering in the process of developing our 2016-2021 Strategic Plan. We invite all Lions throughout MD-36 to participate in the process of helping OLSHF identify our strengths and weaknesses as well as assisting us in identifying potential opportunities and threats that may exist in the future. OLSHF Community Assessment forms are available for Lions to use in their community and I encourage you to contact Doug Thompson if you'd like information on how to participate.
- The **OLSHF Hall of Fame Gala** was held on Saturday, October 3rd at Tualatin Valley Country Club. Inducted that evening were Gresham Breakfast Lion **Carl Berry** (posthumously) and Lions **Art Carroll, Keith Price** and **Bill Taylor**. Nominations for the 2016 Hall of Fame can be made by any MD-36 Lion and can be made starting in January.

Report Multiple District 36 Lions Alert Team

The Lions Alert Team has a mission to reach out to our Oregon Lions Clubs and offer preparedness programs. The next step of the mission is to have Alert Team members from each Oregon District and from each Lions Club. Once we are prepared as individuals and we know our families are safe, we can then step out and help others.

Action Plan: Schedule programs around the state and reach out to clubs with a presentation from our Lions Alert Team members.

Follow-up on the contacts made at the State Convention in Seaside.

Presentations have been made to some Oregon Lions Clubs. The Lions Alert Team has attended ORVOAD (Oregon Volunteers Active in Disaster) meetings and offered assistance to victims of fire disasters in Oregon. Information is still being gathered on the needs of the fire victims in Grant County, Baker County and Warm Springs. As more concrete needs are know they will be shared with Oregon Lions.

There is a need in Grant County for counseling to fire victims and first responders, there is also concern of moving into winter and the threat of flooding during heavy rain or heavy snow and a rapid snow melt.

There are Lions Alert Team members who are active in COADs (County Organizations Active in Disasters) who are forming, planning and training for present and future disasters in their counties. We would urge local Oregon Lions Clubs to become active in these COAD groups. Some of those groups are in Clackamas, Douglas, Klamath, Yamhill/Polk, Marion, Clatsop, Washington and Multnomah counties.

Keys to focus on: Preparedness, Training, Map Your Neighborhood, Contact County Emergency Managers and reach out to neighboring Oregon Lions where disaster has occurred.

November 14, 2015 Multiple District 36 Finance and Budget Committee report

The Multiple District 36 Finance and Budget committee last met on November 9, 2015. At that meeting we reviewed with Executive Administrator PCC Vince Bishop the MD 36 financial statements for the fiscal year ended June 30, 2015 and the IRS Form 990-EZ for the same period. Our committee still has concerns regarding MD 36 programs such as the Mexico Vision Mission and NW Leadership programs which have not been reporting their financial activity on the MD 36 annual financial statements.

We also reviewed with Executive Administrator Vince Bishop the September 30, 2015 year to date financial statements.

We continued the discussion from previous committee meetings regarding elimination of the requirement in the MD 36 policy manual requiring a CPA to prepare an annual compilation or review of the MD 36 annual financial statements. Currently, we are not using an independent CPA to perform this service nor can we afford to hire a CPA to do this service. Our committee recommends that we eliminate this requirement and instead add the requirement that either a duplicate copy of all MD 36 monthly bank statements be sent directly to one or more members of the MD 36 Finance and Budget Committee for their review or to allow them read only electronic access to all activity in MD 36 bank accounts.

We also had a telephone conference with PID Ed Gear regarding the financial impact and current status of the search committee for replacing Executive Secretary Glynis Beyerlin.



Step 2: Select a location for your food drive. Successful places include schools, office buildings, places of worship or community centers. Secure permission to hold your food drive from the chosen location. Several clubs have successfully partnered with local grocery stores to place collection barrels at the main entrance, staffed by Lions who share the goal of the food drive with customers entering the store (a list, as below, can be handed to entering customers along with an explanation).

Step 3: Begin planning your food drive. Choose a name or theme for your drive and set a goal for the amount of food that you want to collect. Enlist the help of friends, co-workers, neighbors and your local Leo Club or Boy Scout or Girl Scout troop.

Step 4: Promote your food drive. This allows community residents time to choose food from their pantries or to buy extra food when grocery shopping. Enlist the help of your club Public Relations Chair to promote this event. Decorate collection containers for the food donations. Place flyers or posters in highly visible places. Use newspaper ads, phone calls and e-mails to promote

the drive. Announce your food drive on your club web site, Facebook page and other social media sites.

Step 5: Collect food for the hungry. If possible, hold your food drive for several consecutive days or weekends.

Step 6: Deliver your collected food to the to the food bank or pantry selected.

Step 7: Send "thank you" letters to individuals or organizations who participated, either as the location for the drive or as sponsoring donors and public relations assistance. Publicize your successful drive in community newspapers, on your club web site and on social media sites.

Step 8: Report the success of your food drive at your club's MyLCI activity report page, preferable during the week of January 10-16.

Food Items Most Needed

100% fruit juice (boxes, cans, bottles)
Canned meat such as tuna, salmon, chicken
Canned vegetable and fruit with no added sugar
Chunky soups, beef stew, chili
Dry macaroni and cheese boxes
Peanut butter and jam/jelly
Powdered milk/shelf stable milk boxes
Brown rice, dry and canned beans
Pasta and sauce
Aim for low sugar, low sodium or no salt items for better health

Please do not collect fresh fruit and vegetables at food drives; perishables are difficult to keep fresh and undamaged.
